Upcoming OVW Legal Services Solicitation this Fall!

The LAV team is excited to announce a new funding opportunity, coming this fall! The Expanding Legal Services Initiative (ELSI) is intended to enable organizations that do not currently offer comprehensive legal services to establish a program that provides legal representation to victims of domestic violence, sexual assault, dating violence, and stalking. Eligible applicants include non-profit organizations and tribal governments or tribal organizations that seek to establish a legal program. The LAV team is hosting virtual events on September 15th and October 6th from 2:00 – 3:30pm ET to provide prospective applicants with more information and to answer questions. The Initiative

The Expanding Legal Services Initiative is intended to enable eligible organizations that do not currently offer legal services to establish a program that provides legal representation to victims of domestic violence, sexual assault, dating violence, or stalking.

Eligible Applicants

Eligible applicants include non-profit organizations and tribal governments or tribal organizations that do not currently offer comprehensive legal services but desire to establish a program to provide legal representation to victims.

OVW Celebrates Disability Pride Month



Image Description: Each color of the Disability Pride Flag represents a different type of disability: physical (red), cognitive and intellectual (yellow), invisible and undiagnosed (white), psychosocial (blue), and sensory (green). The charcoal background symbolizes mourning and rage for the victims of ableist violence and abuse, and the colored bands are placed diagonally to convey persons with disabilities "cutting across" societal barriers.
